PRESIDENT – Christopher Ryan

Dear Fitzroy Tennis Club members,

At the time of last year's Annual General Meeting (AGM), FTC was closed due to COVID lockdown, but, to the relief of all, we finally re-opened on the 29th September. The remaining restrictions gradually eased during October, so that tennis was almost back to normal in November. We were all happy and excited to once again see and play with our fellow club members. Tennis as a sport has been booming since, and FTC has shared in the growing popularity of our game.

The club's redevelopment plans were also in limbo at last year's AGM and the Committee faced a stressful period immediately before Christmas as we lobbied for FTC under the threat of insufficient funding. The strong support of our neighbours in the Edinburgh Gardens Sporting Community (EGSC) and local MP Richard Wynne's commitment to the project saw the necessary funding approved, and the project is now on track to begin early in 2023. The Committee has begun discussions with nearby tennis clubs to investigate ways to mitigate the disruption which construction will inevitably cause.

An emerging theme over the last year has been the club's willingness to explore how we can improve by looking at how and why we do what we do and being prepared to listen and try new things. The new social tennis opportunities on Thursday evenings and Tuesday mornings along with the new Facebook members' group are good examples. The Committee is keen to expand the opportunities for members to meet and play, and we have established a special sub-committee to review our annual schedule of events to ensure we are as representative and inclusive as possible with the offerings we provide to members.

Another example is the 2022 Club Championships where we tried out the benefits of utilising a tournament manager, referee and tournament software, with considerable success. In a break with tradition, we also split off the Delmo Carli round-robin tournament to its own date in September and have seen almost a doubling in the number of entries on last year.

Other changes and experiments begun in the last year are the arrival of a ball-vending machine, a new ball-recycling partner, and a change in our electricity supplier to one with a much better rating as a green provider.

The post-lockdown boom in tennis has provided plenty of business for our coaching team at Racquet Lab who continue to expand their range of offerings. Despite a worldwide shortage of tennis coaches, Luke and Bryce have managed to put together a full team of quality coaches, who are enhancing the game for juniors and adults at FTC.

I also want to recognise the invaluable contributions of our caretaker Michael Valiente who reached the milestone of 25 years with FTC in December, and our Office Adminstrator, Kata Pinter, as well as the essential assistance on many fronts from our

The club is also very lucky to have many members who are not on the committee but have contributed generously, including: Peter Geha and Tony Appleyard with maintenance, Simone Tracey, Raewyn Crighton and Luke Phillips with new social tennis arrangements, Adam Huddlestone, Sara Kernick, and Bryce Devlin with comps, Chris Canavan with the Club Championships, and Tim Dun with the Juniors.

FTC continues to be in a very healthy financial position.

Profit and Loss (Appendix 2) - points of interest:

- With lockdowns ending in October 2021, bookings via Book-a-Court continued to be strong given limited competition for the Spring Season.
- Coaching revenue also increased once lockdowns ended.
- The Club benefited from another Government Covid-19 grant of \$20,000 for the Cashflow Boost.
- Membership revenue reduced due to discounted membership fees but membership is still very strong.
- Expenses for the Club Championships increased due to contracting external support for the competition

Balance Sheet (Appendix 1):

- The Club rolled over a new term deposit for \$300,000 in July 2021
- The Club continues to build its cash reserves in readiness for the Redevelopment and potential future expenses that are not covered by the Project Budget

MEMBERSHIP - Nell White

The total level of membership has increased over the financial year 2021/22 by around 10%. At 30 June there were 526 members.

The growth in Membership is considered to be due in part to the popularity of tennis throughout Covid and the growth population in the local area. The Committee feels that the membership has now reached its practical limit for a club with 6 courts.

Over 60% of members live in the City of Yarra. The makeup of our membership remains constant with 38% female and 62% male, with 14% under 18 years of age and 16% over 65 years.

In response to the COVID-19 restrictions and closure of the Club for extended periods in 2021, the committee provided renewing members with a discount in their fees to the equivalent of 12 weeks. This was the second year that adjustments to membership renewals were made due to Covid.

The structure of the memberships available remained unchanged in 2021/22, with an adult membership costing \$219 for the full year, plus the once-off new membership costs of \$137.

Our thanks go to Kata Pinter who has continued to provide valuable assistance in the administration of memberships.

BRUNSWICK ST OVAL PRECINCT (BSOP) PROJECT – Matthew Russell & Chris Ryan

At the time of last year's AGM, the Brunswick St Oval Precinct Project faced considerable uncertainty, due to Heritage Victoria's rejection of the proposed design for the new football and cricket pavilion adjacent to the grandstand. We were expecting to see new plans released in October, but a major hurdle was thrown up by the revised budget, which significantly exceeded the funding promised by the State Government and the City of Yarra. For a time it looked as if only the football and cricket pavilion could be built, with FTC's new courts and clubhouse postponed indefinitely.

Fortunately, strong support for the BSOP project from local MP and Minister for Planning, Richard Wynne, saw a further \$6.7 million added to the project in the State budget. This meant that the project is fully funded and allowed the City of Yarra Council in May to unanimously approve the new plans and to move ahead into the next phase of development. This includes internal Council review - including items such as incorporating pavilion standards and building standards. This process is expected to take 2-3 months to complete.

The Club Committee has established a sub-committee of interested members to advise on responses to the developing plans and to assist our representatives on the Project Control Group, Chris Ryan and Matthew Russell. The club's BSOP sub-committee is chaired by the President and comprises Cheryl Coughlin, Nell White, Cath Pearl, Matthew Russell, Wayne Stephens and Chris Canavan.

FTC has continued to review and provide strong feedback on the Schematic Design over the past 12 months. The Club has raised numerous points to ensure that we achieve the best outcome for the club in terms of tennis requirements, indoor and outdoor spaces and environmental credentials of the facilities within the overall constraints of the project. We have secured two new courts, resurfacing of all courts, new court infrastructure (lights, fences, etc.), functional outdoor area and practical use of old clubhouse for both storage and coach's office.

The schematic design is now final and there will be only changes to details such as kitchens, storage, finishes, etc from now on. This will ensure the management of the costs and consistency with the town planning requirements and council-approved design.

The project plan currently indicates that construction is due to commence in February 2023. Whether this date will hold is reliant on tender outcomes and any subsequent requirement for project cost management.

FTC is now engaging with other clubs in nearby areas to ascertain availability of court sharing to permit access to courts (at other locations) throughout the construction process. The starting date and duration of disruption to the club's operation is still unknown but is unlikely before mid-2023.

<u>COMPETITION</u> -

North-East Night Tennis Group (NENTG) – Adam Huddlestone

In the last 12 months the night tennis teams have enjoyed great quality tennis together with a reconnection with friends made over many years as we start to play familiar faces again after the pandemic enforced hiatus. We currently have 3 mens teams, 3 ladies teams and 1 mixed team, who recently won the Section 1 flag for a second time - HUGE congratulations to Michelle, Quimby, SJ, Wayne and Matt.

Here's to another fun year playing together.

Saturday comps: Pennant/BRTA – Bryce Devlin, Sara Kernick

Pennant – In 2022 FTC again had one grade 3 team participating in the Tennis Victoria Mens Pennant League. We had 10 players registered in the team and with 8 of those players having their name on the Club Champs honour Boards, we were going into 2022 fairly confident. We were quickly brought back to the real world where we lost 6 - 0 in the very first round to our most immediate competition (Royal Park).

Even with our 10-player all-star roster we were plagued with injuries/Covid isolation and some much needed overseas R&R so we struggled to put a 4 player team in each week. Despite having some tight early rounds we weren't able to gain our first win until week 9, but since then we have gradually built with confidence and have won 3 out of our last 4 rounds. Junior competition tennis continues to thrive at FTC. After a successful Autumn season with 8 teams, Spring season is well under way with 6 boys teams and 2 girls teams having made a strong start. This has had varied attendance with anywhere between 8 and 20 players each Friday evening.
